“provided that civil servants against whom an inquiry, investigation, case or a reference is pending in Anti-corruption Establishment, Federal Investigation Agency, National accountability Bureau or such other’ organization by whatever name called for, more than three (03) years and the delay has not been caused by any reason attributable to the officer, may be recommended for promotion”.

Offices, under their administrative control for compliance.
