WHEREAS it is expedient to amend the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975 in the manner hereinafter appearing:

AND WHEREAS the Provincial Assembly of Baluchis' a. is not in session and the Governor of Baluchistan is satisfied that circumstances exist which render immediate legislation necessary ;

NOW THEREFORE, in exercise of the powers conferred on him by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:—

I. (1) This Ordinance may be called the Baluchistan Assembly Members (Salaries and Allowances) (Amendment) Ordinance, 1975.

(2) It shall come into force at once and shall be deemed to have taken effect on and from the 14th day of April, 1975.

2. In section 2 of the Baluchistan Assembly Members (Salaries and Allowances) Act, 1975 (Baluchistan Act No. II of 1975) herein-after called the said Act, after clause (f) the following new clauses shall be inserted, namely:—

“(g) “Secretary”. means the Secretary of the Assembly”; and

(b) existing clauses (g), (h) and (i) shall be re-lettered as clauses (h), (i) and (j) respectively.

3. In the said Act, after section 5, the following new section ~ell be inserted, namely :—

\*\*5-A CQNTRGLLING OFFICER. The Secretary shall be Controlling Officer for the purpose of travelling allowance admissible under this Act.”.
