WHEREAS it is expedient to amend the  
Baluchistan Board of Intermediate and Secondary  
Education Ordinance, 1977 (X of 1977), for  
the purpose hereinafter appearing;

AND WHEREAS the Governor is satisfied  
that circumstances exist which render it neces-  
sary to take immediate action;

NOW, THEREFORE, in exercise of the  
powers conferred by Article 128 of the Con-  
stitution, read with Article 2 of the Provisional  
Constitution Order, 1981 (C.M.L.A. Order No.  
1 of 1981), the Governor of Baluchistan is  
pleased to make and promulgate the following  
Ordinance:-

1. (1) This Ordinance may be called the

Baluchistan Board of Intermediate and Secondary  
Education (Amendment) Ordinance, 1983.

(2) It shall come into force at once.

2. In the Baluchistan Board of Intermediate  
and Secondary Education Ordinance, 1977  
(X of 1977), in Section 13, after sub-section (7),

the following new sub-section shall be inserted,  
namely:-

(8) The Controlling Authority shall have  
the powers to place the services of  
any of the officers or other employees  
of the Board at the disposal of Govern-  
ment or other institution for such  
period and on such terms and con-  
ditions as may be determined by it;

Provided that such terms and conditions shall not be less favourable than those admissible to him immediately before his transfer.”
