Act, 1923 (Act No. IV of 1923) in the manner hereinafter appearing;

It is hereby enacted as follows:-

12, (1) This Act may be called the Balochistan Mines
(Amendment) Act, 2011.

(2) It shall extend to the whole of Balochistan
except the tribal Areas.

(3) It shall come into force at orca

2. in the Mines Act 1923 (Act inc IV. of 1923),
hereinafter referred as the said Act 1: soction 30-A, in
clause (d). for the words "duty of excise' Uie words "duty
of Safety / Rescue / Training" and for the words " three
paisa" the words "five rupees" shail be substituted

3. In the said Act. in section 36, after the word " fine"
the words "not less than four thousand rupees" shail be
inserted and for the words "four hundred" the words "six
thousand" shall be substituted.

4. Inthe said Act. in section 39, after the word "fine" the
words "not less than five thousand rupees" shall be
inserted and for the words. " two thousand" and " two

hundred” the words “twenty thousand” and “five hundred” shall be substituted, respectively.

In the said Act. in section 40, in sub section(1) ,

for the words 'which may extend to four
thousand rupees" the words: "not less than forty
thousand rupees",

"for the words 'which may extend. to two

thousand rupees" the words "not less than ten
thousand rupees" shall be substituted.
