Preamble. WHEREAS it is expedient further to amend the Baluchistan Ministerial (English) Service Joint Cadre (Dissolution) Ordinance, 1971, for the purpose hereinafter appearing;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by

Article 128 of the Constitution, read with Article 2 of the Provisional

Constitution Order, 1981 (C.M.L.A. Order No. I of 1981), the Governor

of Baluchistan is pleased to make and promulgate the following Ordinance; ‘

Short title and 1. (1) This Ordinance may be called the Baluchistan Ministerial (English) Service Joint Cadre (Dissolution) (Amendment) Ordinance, 1983.

It shall come into force at once and shall be deemed to have effect from 28th September, 1971.

Amendment to - In the Schedule of the Baluchistan Ministerial (English) Service Joint Cadre (Dissolution) Ordinance, 1971\* after Serial No. 382, the following shall be added, namely;—

“382—A. Mr. Abdul Majid Shahwani. —do— Clerk of Court to  
; Senior Civil Judge  
Quetta”.
