Further to amend the Baluchistan Motor Vehicles Ordinance,
1965 (W.P. Ordinance No. XIX of 1965).

WHEREAS, it is expedient to amend the Baluchistan
Motor Vehicles Ordinance, 1965 (Ordinance No. XIX of 1965),
in the manner hereinafter appearing;

It is hereby enacted as follows:—

1. (1) This Act may be called the Baluchistan Motor
Vehicles (Amendment) Act, 2017.

(2) It shall come into force at once.

2. In the Baluchistan Motor Vehicles Ordinance, 1965
(W.P. Ordinance No. XIX of 1965), hereinafter referred to as
the said Act, in section 116-A after the words “charge on”the

words “spot any person committing in his view an offence
mentioned in” shall be substituted.

3. In the said Act, for “The Twelfth Schedule” the following shall be substituted, namely:—

also pay a meagre amount of Rs. 500/- as fine easily. These lesser penalties encourage the criminal elements for repeatedly using the tinted glasses during their unwanted activities.”
