An Ordinance to provide for regulation of the planning and construction of building, and purchase and provision of facilities, equipments and furniture for Educational Institution and maintenance of record in connection with implement of Education Projects in the Province of *[Balochistan].

WHEARES it is expedient to regulate the planning, preparation of estimates for, according technical and administrative approval thereto and construction of buildings, the provision of facilities and purchase of equipments and furniture for the Educational Institutions in the Province of *[Balochistan];

AND WHEARES the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977, (CMLA Order No. I of 1977), and in exercise of all powers enabling him in that behalf, the Governor of [Balochistan] is pleased to make and promulgated the following Ordinance:—

1. (1) This Ordinance may be called the [Balochistan] Education Project (Implementation and Regulation) Ordinance, 1981.

(2) It shall come into force at once.

(3) It shall apply to such area and/or Projects as the Government may by Notification specify.

force shall apply to any matter regulated by this Ordinance and rules made thereunder, unless the context otherwise requires.

3. In this Ordinance, unless there is anything repugnant in the subject or context:—

(a) “Architect” means the architect appointed by the Project Committee;

(b) “Consultant” means the Consultants appointed by the Project Committee;

(c) “Department” means a Department of the Government of 7[Balochistan];

(d) “Government” means the Government of 8[Balochistan], in the appropriate Department;

(e) “Project Director” means the Project Director appointed by the Government under section 4;

(f) “Project Engineer” means the Engineer appointed by the Government under section 4;

(g) | “Prescribed” means prescribed by the Rules made under this Ordinance;

(h) “Project Committee” means the Committee appointed by the Government under section 5;

(j) “Secretary” means the Secretary to the Government of 9[Balochistan] in appropriate Department; and

(k) “Superintending Engineer” means the Engineer appointed by the Government under section 4.

4. (1) The Government may, by notification appoint any

officer to act as Project Director, Project Engineer and Superintending Engineer in connection with the implementation of an Education Project to which this Ordinance is made applicable.

(2) The Government may fix the pay, allowances and remunerations of the officers appointed under sub-section (1).

(3) The Government may, assign such duties and functions to the officers, appointed under sub-section (1), as may be prescribed.

5. (1) The Government may, by notification constitute a

Project Committee, consisting of not more than seven member, for the purpose of supervising the implementation of an Education Project and regulating the Procedure for maintaining record of various agencies in respect of the activities relating to the Project, to which this Ordinance in made applicable.

(2) The Government may, assign such functions and power to the Project Committee as may be prescribed.

(3) One of the members shall be appointed as Chairman of the Project Committee.

(4) The Project Director shall be member/ convener of the Project Committee.

(5) The Government may fix such remuneration for the members of the Project Committee as it may deem fit.

6 (1) The Government may make Rules consistent with the Provisions of this Ordinance to carry out the purposes of this Ordinance.

(2) In particular and without prejudice to the generality of foregoing powers, such rules may provide for:-

(a) The terms and condition of employment of Architects, Consultants and Technical assistants.

(b) The Payment to the Architect, Consultant and Technical assistance;

(c) Organization of the Project Office of Implementation Unit.

(d) The duties and responsibilities of the Project

Director, Superintending Engineer and any other official employed for the purpose of this Ordinance.

(e) Preparation, scrutinising and approval of estimates, Tender Documents, Drawings, Plans;

(f) Floating and approval of Tender and issue of Work Orders.

(g) Recording of measurements and preparing of bills for work done, supplies made or service rendered.

(h) Checking of bills and payment thereof.

(j) Withdrawal of funds from the Treasury.

(k) The accounting of — expenditure,
maintenance of accounts, prescribing
account books, Registers.

(1) The submission of returns and
statements.

(m) The procurement of stores, equipments,
furnitures and supplies.

(n) The conduct of audit of the accounts.

7. Notwithstanding anything contained in this Ordinance, all acts done, Project Committee Constituted, Officers, employees Consultants appointed, tenders, floated, drawings, plans and documents prepared, work orders issued, payments made, accounts maintained, Reports and Returns complied, stores, equipment and supplies purchased and audit conducted by the Government in connection with any project to which this Ordinance is made applicable shall be deemed to have been validly appointed, floated, prepared, issued, made, maintained, compiled, purchased and conducted under this Ordinance, from the date of commencement of such project.

Provided they are generally in accordance with the provisions hereof.
