An Ordinance further to amend the Court Fees Act,  
1870 (VIL of 1870), in its application to the Province of  
Balochistan.

WHEREAS it is expedient further to amend the Court  
Fees Act, 1870, in its application to the Province of  
Balochistan for the purpose hereinafter appearing;

AND WHEREAS the Governor is satisfied that  
circumstances exist which render it necessary to take immediate  
action;

NOW, THEREFORE, in exercise of the power  
conferred by Article 128 of the Constitution, read with Article 2  
of the Provisional Constitution Order, 1981 (C.M.L.A. Order  
No.1 of 1981), the Governor of the Balochistan is pleased to  
make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Court Fees  
(Balochistan Amendment) Ordinance, 1984.

(2) It shall come into force at once.

2. In the Court Fees Act, 1870, in its application to the  
Province of Balochistan, hereinafter referred to as the said Act,  
Sections 19-A, 19-B, 19-E, 19-F, 19-G, 19-H, 19-I, and 19-J

shall be omitted.

3. In the said Act, in SCHEDULE-1, Articles 9 and 10 shall be omitted.

4. In the said Act, for clauses (a) and (b) of Article 12 of SCHEDULE-II, the following shall be substituted, namely:-

(a) Probate of a will or letters of | Fourteen administration with or fupees.
