It is hereby enacted as follows:-

i, iW This Act may be called the Balochistan Public Service
Commission (Amendment) Act. 2004.

G) It shall come into force at once.

2 In the Balochistan Public Service Commission Act. 1989
hereinafter referred to as the said Act. in section 3:-

(a) In sub section (3), for the word "Government" the words
"Governor in consultation with the Chief Minister" shall be
substituted.

(b) after sub section (3). the following proviso shall be added:-

~Provided that no person below the age of 55 years shall
be appointed as Chairman or Member of the Commission".

In the said Act. for section 4, the following shall be substituted:-

4 Terms of office of Chairman and Member.

4 The term of office of the Chairman or a Member of the
commission shall be five years:

Provided that a Member. who immediately before his
appointment as Member was holding a post in the service of Pakistan may
be transferred in public interest before the expiry of his term of office.

(7) The Chairman or a Member may resign his office by writing under his hand addressed to the Governor.

A. In the said Act. in sub section (2) of section 6. after the words. figure and comma ~ Provisions of section 4.° The words “recommended to the Governor to” shall be inserted.

In the said Act. section 7. shall be omitted.

6. Lhe Balochistan Public Service Commission Ordinance, 2003 (IIL of 2003) is hereby repealed.
