WHEREAS, it is expedient to amend the Balochistan Wildlife (Protection, Preservation, Conservation and Management) Act, 2014, (Act No. XV of 2014), in the manner hereinafter appearing:

It is hereby enacted as follows. -

1. (1) This Act may be called the Balochistan Wildlife (Protection, Preservation, Conservation and Management) (Amendment) Act, 2015.

(2) It shall come into force at once.

2. In the Balochistan Wildlife (Protection, Preservation, Conservation and Management) Act, 2014, (Act No. XV of 2014), hereinafter referred as "the said Act", in section 34,—

(a) in sub-section (6), at the end before full-stop, the following words shall be inserted, namely:

"except for strategic requirements by taking precautionary measures for protection of flora and fauna in the Protected Area", and

(b) in 'sub-section (7), after the words 'local communities' a comma and the word, "federation" shall be inserted.

3. In the said Act, in section 35, in sub-section 4 at the end before full-stop, the following words shall be inserted, namely

"or for any activity of national importance with

‘sound precautionary measures to enhance the conservation value of the Park in terms of biodiversity and other elements of nature”
