Whereas it is expedient to amend the Balochistan  
Prohibition of Expressing Matters on Walls Ordinance  
2001; :

It is hereby enacted as follows:-

a (1) This Act may be called the Balochistan  
Prohibition of Expressing Matters on Walls (Amendment)  
Act, 2016.

(2) It shall come into force at once.

2. In the Balochistan Prohibition of Expressing  
Matters on Walls Ordinance 2001 (Ordinance No. LI of  
2001), hereinafter referred to as the said Ordinance, in  
section 2, for the words, figure and commas "fine not  
exceeding Rs. 5,000/-", the words with comma "fine  
which shall not be less than twenty five thousand rupees,  
nor more than one hundred thousand rupees" shall be  
substituted.

3 In the said Ordinance, after Section 2, the  
following new section shall be inserted, namely:-

"2-A. Cognizance and summary trial. - (1)  
An offence under this Ordinance shall be  
cognizable and not bailable.

(2) A Magistrate of the first class shall conduct

“the trial of an offence under Balochistan  
Prohibition of Expressing Matters on Walls  
Ordinance 2001 in accordance with the provisions  
of Chapter XXII of the Code of Criminal  
Procedure, 1898 (V of 1898).”
