No.SOR-II_(17)4/2018- D od 22 In exercise of the powers conferred by Section 25 of the Balochistan Civil Servants Act, 1974 (Act No. IX of 1974), the Government of Balochistan is pleased to make the following amendments in the Balochistan Public Service Commission Officers (BPS-16 and above) Service Rules, 2016 (Service Rules No. XXXI of 2016),

namely:-
