In the said Act, after section 13, the following new section

"13A. Validation. Any action taken, contract or agreement relating to, or in respect of or in connection with the affairs of the Bolan Medical College, executed, entered into, varied or revoked hereto before by any officer of the Pakistan Public Works Department or by, or on behalf of, the Board of Governors of the said College, and all other acts incidental thereto, are, notwithstanding any thing contained in the said Act, or any other law or instrument having the force of law for the time being in force or any decision of any court, hereby declared to. have been, and shall be deemed always to have been, validly taken, executed, entered into, varied or revoked or done, and shall not be called in question in any court on any ground whatsoever.

The Bolan Medical College (Board of Governors)

(Amendment) Ordinance, 1991 (IX of 1991), is hereby repealed.
