(BALOCHISTAN AMENDMENT)  
ORDINANCE, 2001

(Balochistan Ordinance XXXII of 2001)

[6<sup>th</sup> October, 2001]

An Ordinance further to amend the Code of Criminal  
Procedure, 1898.

WHEREAS, it is expedient further to amend the Code  
of Criminal Procedure, 1898 (Act V of 1898) for the purpose  
hereinafter appearing;

AND WHEREAS, the Governor of Balochistan is  
satisfied that circumstances exist which render it necessary to  
take immediate action;

NOW THEREFORE, in pursuance of Article 4 of the  
Provisional Constitution (Amendment) Order, 1999 (Chief  
Executive's Order No 9 of 1999), and in exercise of all powers  
enabling him in that behalf, the Governor of Balochistan is  
pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Code of  
Criminal Procedure (Balochistan Amendment) Ordinance,  
2001.

(2) It shall come into force on the 14<sup>th</sup> day of  
August, 2001.

(3) It shall extend only to "B" areas of Balochistan.

2. In the Code of Criminal Procedure, 1898, hereinafter

referred to as the said Code, in section 62, for the words "District Superintendent of Police", the words "District Administrative Officer" shall be substituted.

3. (1) In the said Code, in sub-section (b) of section 128 for the full stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:—

"Provided that for dispersing any assembly, firing shall not be resorted to except under the specific directions of an

This Ordinance was made by the Governor of Balochistan on 2<sup>nd</sup> October, 2001; and published in the Balochistan Gazette (Extraordinary) No. 157, dated 6<sup>th</sup> October, 2001.

4. In the said Code, in section 129, for the words "the police officer of the highest rank not below an Assistant Superintendent, or Deputy Superintendent of Police" the words "the District Administrative Officer or Assistant District Administrative Officer" shall be substituted.

5. In the said Code, in section 130, in sub-section (1);

(a) for the word "a police officer of the highest rank not below an Assistant Superintendent, or Deputy Superintendent, of Police" the words and commas "a District Administrative Officer or Assistant District Administrative Officer" shall be

substituted; and

(b) after the words "or such police officer", the words "such District Administrative officer or Assistant District Administrative Officer" shall be inserted.

6. In the said code, in section 131,—

(a) for the word "police officer of the highest rank not below an Assistant Superintendent, or Deputy Superintendent, of Police" the words and commas "a District Administrative Officer or Assistant District Administrative Officer" shall be

substituted; and

(b) for the words " a police officer not below

the rank of Assistant Superintendent, or Deputy Superintendent, of Police” the words and commas “ a \_ District Administrative Officer or Assistant District Administrative Officer” shall be substituted; and

(c) for the words “such police officer” the words “such District Administrative Officer or Assistant Administrative Officer” shall be substituted.
