

GRANT-IN-AID POLICY

- a. 30% of grant in aid will remain at the disposal of Administrative Departmental at provincial level for repair /renovation /rehabilitation of religious/worship places or holy sites including Mandirs, Churches, Temples/ other religious/ worship places or holy sites of minority Communities including graveyards & shamshanghats.
- b. 25% of grant-in-aid will be allocated for festivals/ religious & sports events of minority communities at the disposal of Department /Minister In-charge/Parliamentary Secretary/ Advisor to Chief Minister.
- c. 10% fund out of grant-in-aid will be placed at the disposal of Hon'ble chief Minister/Parliamentary Secretary Minorities Affairs/ Advisor for Minorities Affairs Provincial / Department of Minorities to meet an/all emergencies including terrorist attacks, accidents, natural disasters, epidemics or any such like unforeseen circumstances culminating in the hardships of members of minority community in any part of the Province.
- d. 15% of funds of grant-in-aid will be allocated for the patient's/ fire victims/ terrorism/ road accident victims of the minority community in and placed at the disposal of all Deputy Commissioners of the Province in proportionate to the population of minorities in a given district as per the figure in last census.
- e. 10% of funds out of grant-in-aid will be allocated for poor /needy people/ financial assistance for marriage & dowry to the poor families of minorities communities and placed at the disposal of the disposal of all Deputy Commissioners of the Province in proportionate to the population of minorities in a given district as per the figure in last census.
- f. 10% of fund out of grant-in-aid will be booked against scholarships for the competent students of Minority Community and placed at the disposal of all Deputy Commissioners of the Province in proportionate to the population of minorities in a given district as per the figure in last census.
- g. The accumulative left-over/saving amount from all above categories, if available, will be utilized for purchase of physical assets like ambulances, water bowsers, funeral bus etc. with the prior approval of Provincial Committee for Minorities.

2. Financial Break-up & One-time maximum ceiling:

Consequent upon the above approval/decision, the breakup & maximum ceiling fixed against of all categories against allocated amount of Rs.200 Million

prior approval of the Provincial Committee for Minorities will be distributed by Administrative

Department on need basis.
