ORDINANCE, 1962

(W.P. Ordinance I of 1962)

[6" January, 1962]

An Ordinance to extend the *[Balochistan] Laws to
Gwadar.

WHEREAS Gwadar, being ceded to Pakistan on the
eighth day of September, 1958, became on that day one of the
territories included in Pakistan;

AND WHEREAS Article 2 of the Gwadar (Government
and Administration) Order, 1958, provides that until otherwise
determined by competent authority, Gwadar shall, for purposes
of government and administration, and all matters connected
therewith, constitute part of the Mekran District in the Kalat
Division of the Province of *[Balochistan];

AND WHEREAS it is expedient to apply to Gwadar all
*[Balochistan] laws which are or may hereafter be in force in
the aforesaid Mekran District;

NOW, THEREFORE, in pursuance of the Presidential
Proclamation of the seventh day of October, 1958, and having
received the previous instructions of the President, the
Governor of West Pakistan, in exercise of all powers enabling
him in that behalf, is pleased to make and promulgate the
following Ordinance:—

1. This Ordinance may be called the Gwadar (Application
of *[Balochistan] Laws) Ordinance, 1962.

2. (1) All *[Balochistan] Acts including all Orders and
other enactments, and all notifications, rules by laws or
directions made or issued thereunder, which were in force in the
District of Mekran in the Kalat Division of the Province of
[Balochistan] immediately before the eighth day of September,

1958 (hereinafter referred to as the "said day"), shall be deemed

to have been in force in Gwadar with effect from the said day, and shall continue in force, subject always to such amendments as may have been or may be made therein by or under proper authority.

(2) For the removal of doubt, it is hereby declared that any '[Balochistan] Act which became applicable to the Mekran District, on or after the said day, shall extend, or shall be deemed to have extended to Gwadar.

Savings. 3. (1) Any law or legal instrument having the force of law in Gwadar (hereinafter called Gwadar law) in force immediately before the said day, and corresponding to the provisions of any '[Balochistan] Act applied by the preceding section, shall stand repealed on and from the said day, and shall be deemed to have been re-enacted by such '[Balochistan] Act as if the Gwadar law were '[Balochistan] Act and the provisions of the '[Balochistan] General Clauses Act, 1956¹, shall apply accordingly.

(2) Notwithstanding the provisions of sub- section (1), anything done, action taken, right accrued, or liability, penalty, forfeiture or punishment incurred, under any Gwadar law on or after the said day and immediately before the commencement of this Ordinance shall be deemed to have been validly done, taken, accrued or incurred, as the case may be, and the '[Balochistan] Act by which such Gwadar law is deemed to have been re-enacted shall, to that extent, be deemed not to have come into force during that period.

(3) Nothing in section 2 shall be deemed to have or ever to have had the effect of retrospectively creating any offence or of retrospectively enhancing the punishment for any offence provided for in any law for the time being in force.

(4) Without prejudice to the other provisions of this Ordinance, the repeal by this Ordinance of any Gwadar law shall not affect—

(a) the previous operation of any Gwadar law so repealed or the validity, invalidity, effect or consequences of anything already done or suffered thereunder; or

(b) any right, title, privilege, obligation

or liability, acquired, accrued or incurred thereunder, or any release or discharge, already granted, of or from any debt, penalty, obligation, liability, claim or demand, or any indemnity already granted, or the proof of any past act or thing; or

(c) any penalty, forfeiture or punishment incurred in respect of any offence committed against any Gwadar law so repealed; or

(d) any investigation, legal proceeding or remedy in respect of any such right, title, privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid;

and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty, forfeiture or punishment may be imposed, as if this Ordinance had not been promulgated; nor shall this Ordinance revive or restore anything not in force or existing at the time of its commencement or affect any law in which any Gwadar law hereby repealed has been applied, incorporated or referred to, or affect any principle or rule of law, or established jurisdiction, form, or cause of pleading, practice, or procedure, or existing usage, custom, privilege, restriction, exemption, office or appointment, notwithstanding that they respectively may have been in any manner affirmed, recognized or derived by, in or from any Gwadar law hereby repealed.

4. The "[Balochistan] (Gwadar) Extension of laws Ordinance, 1959¹, is hereby repealed.
