NOTIFICATION

No.SOR-II (17)5/2013-S&GAD/2083-210Y tn exercise of the powers conferred by rule 10 read with clause (a) of sub-section 2 of section 3 of the Balochistan Public Service Commission Act, 1989 (Act No. II of 1989), the Government of Balochistan is pleased to make the following amendments in the Balochistan Public Service Commission Conditions

of Service of Members Regulations, 2015, namely:-

In the aforesaid Rules PART-II-LEAVE, for the existing rules 6 and 7, the following shall be substituted, namely:-

Rule-6. Leave. (1) The Chairman who on the date of his appointment was in service of Pakistan may be granted leave by the Appointing Authority under the rules applicable to him immediately before his appointment and his service as Chairman shall count for such leave;

(2) The Member who on the date of his appointment was in service of Pakistan may be granted leave by the Chairman BPSC under the rules applicable to him immediately before his appointment and his service as member shall count for such leave.

Rule-7. (1) The Chairman who on the date of his appointment was not in service of Pakistan may be granted leave by the Appointing Authority as follows:-

(a) On leave salary equivalent of full pay upto one eleventh of period spent on duty as Chairman, subject to maximum of four months at one time; and

(b) On medical certificate a leave salary equivalent to present pay upto two eleventh of the period spent on

duty as Chairman, subject to Maximum of three months at one time.

(2) The Member who on the date of his appointment was not in the service of Pakistan may be granted leave as follows:-

(a) Upto 15 days leave may be granted by the Chairman;

(b) On leave salary equivalent to full pay upto one eleventh of period spent on duty as Member, subject to maximum of four months at one time may be granted by the Appointing Authority; and
