WHEREAS it is expedient further to amend certain land laws in the manner hereinafter appearing; :

It is hereby enacted as follows:-

(1) This Act may be called the Balochistan Land Laws  
(amendment) Act, 2009.

(2) It shall come into force at once.

may be, all the powers, and discharge all the  
duties, of the Commissioner or Collector, as  
the case may be under this Act."
