An Ordinance to amend the Provincial Small Cause Courts Act, 1887 in its application to the Province of West Pakistan.

Preamble. WHEREAS it is expedient to amend the Provincial Small Cause Courts Act, 1887, in its application to the Province of West Pakistan, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly of West Pakistan is not in session and the Governor of West Pakistan is satisfied that circumstances exist which render immediate legislation necessary;

NOW, THEREFORE, in exercise of the powers conferred on him by clause (1) of Article 79 of the Constitution', the Governor of West Pakistan is pleased to make and promulgate the following Ordinance:—

Short title and 1. (1) This Ordinance may be called the Provincial Small Cause Courts (West Pakistan Amendment) Ordinance, 1966.

(2) It shall come into force at once.

Amendment of 2. In the Provincial Small Cause Courts Act, 1887 in its section 15, Act application to the Province of West Pakistan, hereinafter IX of 1887.

(i) for the comma and the words "the Provincial Government", the words and comma "and subject to any directions which the Provincial Government may give in this respect, the High Court," shall be substituted; and

(i1) for the words "two thousand", the words "five thousand" shall be substituted.

3. In the said Act, in section 27-A, in sub-section (1), for the words, commas, brackets and figures "one thousand rupees or, where the Court is empowered under sub-section (3) of section 15, two thousand rupees", the words, commas, brackets and figures "two thousand rupees or, where the Court is empowered under sub-section (3) of section 15, five thousand rupees" shall be substituted.
