ORDINANCE

further to amend the Societies Registration Act, 1860, in its application to the

Province of Balochistan.

WHEREAS it is expedient further to amend the Societies Registration Act, 1860 (XXI of 1860). in its application to the Province of Balochistan for the purposes

hereinafter appearing:

AND WHEREAS \_\_ the Provincial Assembly of Balochistan is not in session and the Governor of Balochistan is satisfied that circumstances exist which render it

necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution of the Islamic Republic of Pakistan, 1973, the Governor Balochistan is

pleased to make and promulgate the following Ordinance :-

1. Short title and commencement. (1) This Ordinance may be called the Societies

Registration (Balochistan Amendment) Ordinance, 2007.

(2) It shall come into force at once.

2. Amendment of section 21, Act XXI of 1860. In the Societies Registration

Act, 1860. for section 21, the following shall be substituted, namely:-

"21. Registration of Deeni Madaris. (1) All Deeni Madaris by whatsoever name called shall not operate without getting themselves registered as under,

namely:-

(i) The Deeni Madaris existing before the commencement of the Societies Registration (Balochistan Amendment) Ordinance, 2007 if not already registered, shall get themselves registered, under this

Act, and

(ii) | The Deeni Madaris which are established after the commencement of the Societies Registration (Balochistan Amendment) Ordinance, 2007, shall get themselves registered within one year of their establishment. .

Explanation One Deeni Maddarassah having more than one campus shall need only one registration.

(2) Every Deeni Maddrassah shall submit annual report of its educational activities to the Registrar.

(3) Every Deeni Maddarassah shall cause to be carried out audit of its accounts by an Auditor and submit a copy of its audit report to the Registrar.

(4) No Deeni Maddarassah shall teach or publish any literature which promotes militancy or spreads sectarianism or religious hatred:

Provided that nothing contained herein shall bar the comparative study of various religious or school of thought or study of any other subject covered by the Holy Quran, Sunnah or Islamic jurisprudence.
