NOTIFICATION

[12% October, 2015]

No. SOR-II (17)5/2015/S&GAD/2771-2820. In exercise of the powers conferred by clause (a) of sub-section (2) of section 3 of the Balochistan Public Service Commission Act 19892 (Act No. II of 1989) the Government of Balochistan is pleased to make the following regulations, namely:—

PART I- GENERAL

1. Short title and commencement. (1) These regulations may be called the Balochistan Public Service Commission conditions of service of Members Regulations, 2015.

(2) They shall come into force at once and shall be deemed to have taken effect from 20-8-2015.

2. Definitions.— (1) In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say:—

(a) “Commission” means the Balochistan Public Service Commission;

(b) “Government” means the Government of Balochistan;

(c) “Member” means a member of the Commission and include the Chairman thereof;

(d) “Schedule” means the schedule attached to these rules;

(e) “Service of Pakistan” means the service of Pakistan as defined in Constitution of Islamic Republic of Pakistan, 19733.

3. Pay Allowances and other perquisites.— The Pay, Allowances and other Perquisites of the Chairman and Members of the Commission shall be in accordance with Schedule-I of these regulations.

4. Pension.— The service as Chairman or Member shall not qualify for pension except that the Chairman or Member who immediately before his such appointment was in service of Pakistan, in whose case such service shall count for pension.

5. Provident Fund.— (1) It shall be permissible for Chairman or a Member, if he so selects to subscribe to the General Provident Fund, in accordance with the rules relating to the General Provident Fund.

(2) The Chairman or a Member who, on the date of his appointment, was in the service of Pakistan, shall be governed for the purpose of Provident Fund and other Fund, by such rules as are applicable to the holders of his grade of pay.

Provided that he shall cease to subscribe the Provident Fund or attaining the age of superannuation in his previous service and the amount standing to his credit in the said Fund after such deductions as are authorized under the rules applicable to him shall become payable to him.

PART II - LEAVE

16. Leave. (1) The Chairman who on the date of his appointment was in service of Pakistan may be granted leave by the Appointing Authority under the rules applicable to him immediately before his appointment and his service as Chairman shall count for such leave;

(2) The Member who on the date of his appointment was in service of Pakistan may be granted leave by the Chairman BPSC under the rule applicable to him immediately before his appointment and his service as member shall count for such leave.

7. (1) The Chairman who on the date of his appointment was not in service of Pakistan may be granted leave by the Appointing Authority as follows:—

(a) On leave salary equivalent of full pay upto one eleventh of period spent on duty as Chairman, subject to maximum of four months at one time; and

(b) On medical certificate a leave salary equivalent to present pay upto two eleventh of the period spent on duty as

Chairman, subject to maximum of three months at one time.

(2) The Member who on the date of his appointment was not in the service of Pakistan may be granted leave as follows:-

(a) Upto 15 days leave may be granted by the Chairman;

(b) On leave salary equivalent to full pay upto one eleventh of period spent on duty as Member, subject to maximum of four months at one time may be granted by the Appointing Authority; and

(c) However, on medical certificate a leave salary equivalent to present pay upto two eleventh of the period spent on duty as Member subject to maximum of three months at one time may be granted by the Appointing Authority.]

8. Other Matters.— In respect of any matter which is not covered by these regulations, a member shall be governed by the rules, applicable to officer of the corresponding pay scale under Government Service or as may in any particular case, be determined by the Government.

9. Repeal. The Balochistan Public Service Commission Conditions of Service of Members Regulations, 1994! are, hereby, repealed.
