3. In the said Act, in section 3, for the word “Deputy

Commissioner” the words “Director of Agriculture (Economics and
Marketing)” shall be substituted.

4, In the said Act, in section 8,

(i) in sub-section (3) for the words “Deputy
Commissioner” the words “Executive District Officer

(Revenue)” and in case there is no “Executive District
Officer (Revenue)” the “Deputy Director of Agriculture
(Economics and Marketing)” shall be substituted.

(ii) In sub-section (4) for the words “Deputy
Commissioner” the words “Executive District Officer
(Revenue)” and in case there is no “Executive District
Officer (Revenue)” the “Deputy Director of Agriculture
(Economics and Marketing)” shall be substituted

5. In the said Act, in section 12, the full stop appearing at the
end of proviso shall be deleted and thereafter the words and full stop
and “Vice Chairman” shall be inserted.

6. In the said Act, in sub-section (1) of section 22, for the words “Deputy Commissioner” the words “Director of Agriculture (Economics and Marketing)” shall be substituted.

Ts In the said Act, in sub-section (2) of section 24, for the words

“District Magistrate” the words “ Session’s Judge” shall be substituted.
