further to amend the Balochistan Assembly Members
(Salaries and Allowances) Act, 1975 (II of 1975).

Preamble. WHEREAS it is expedient further to amend the Balochistan
Assembly Members (Salaries and Allowances) Act, 1975, in
the manner hereinafter appearing;

Short title ft is hereby enacted as follows :-

(1) This Act may be called the Balochistan Assembly

Members (Salaries and Allowances) (Amendment) Act, 1992.

(2) It shall come into force at once and shall be deemed to have taken effect on the 17th day of November, 1990.

Amendment of 2. In the Balochistan Assembly Members (Salaries and Pension) Act, 1975, hereinafter referred to as the said Act, in Section 3, for the words "two thousand rupees" the words "four thousand rupees" shall be substituted.

Amendment of 3. In the said Act, in section 4 for the words "two hundred rupees" the words "four hundred rupees" shall be substituted,

Amendment of 4. In the said Act, in clause (c) of section 5, for the words "rupees one and twenty paise" the words "rupees three and fifty paise" shall be substituted.

Amendment of 5. In the said Act, after section 5-A, the following new section 5-B shall be inserted, namely :-

Section 5-B. Free Travel Allowance. (1) Every Member shall

be provided during a year with vouchers of the value of thirty thousand rupees for the purpose of any journey within Pakistan without payment of any fare by Air or by Rail;

Provided that where a person becomes a member during the course of a year, the value of the vouchers with which he is provided during that year shall not exceed the value which bears the same proportion to thirty thousand rupees as the un-expired portion of the year bears to a year.

(2) A member who does not wish to be provided with such vouchers shall be paid travelling allowance of twenty five thousand rupees in cash during a year for the purpose of any journey.

Amendment of 6. In the said Act, in clause (b) of section 6, for the words "five hundred rupees" the words "three thousand rupees" shall be substituted.

Section 5-B. Free Travel Allowance. (1) Every Member shall

be provided during a year with vouchers of the value of thirty thousand rupees for the purpose of any journey within Pakistan without payment of any fare by Air or by Rail;

Provided that where a person becomes a member during the course of a year, the value of the vouchers with which he is provided during that year shall not exceed the value which bears the same proportion to thirty thousand rupees as the un-expired portion of the year bears to a year.

(2) A member who does not wish to be provided with such vouchers shall be paid travelling allowance of twenty five thousand rupees in cash during a year for the purpose of any journey.

Amendment of 9. In the said Act, in clause (e) of section 9, for the words "three thousand rupees" the words "four thousand rupees" shall be substituted.

per month" the words "rupees five thousand per

month" shall be substituted.

{b) In clause (c) for the word "typist" the words

"Senior Scale Stenographer" shall be substituted.

9. In the said Act after section 7, the following new section

shall be inserted, namely :-

"7-B. Session allowance. A member shail be entitled
to a session allowance of rupees five hundred per day for

actual working days.
