WHEREAS it is expedient further to amend the
Balochistan Assembly Members (Salaries,
Allowances and Privileges) Act, 1975 (Act No. II of
1975), in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. (1) This Act may be called the Balochistan
Assembly Members (Salaries, Allowances
and Privileges) (Amendment) Act, 2014.

(2) It shall come into force at once.

2. In the Balochistan Assembly Members
(Salaries, Allowances and Privileges) Act,
1975 (Act No. II of 1975) hereinafter referred
to as the said Act, in Section 6, clause (e)
shall be omitted.

In the said Act, for the section 6-B the words "Six
thousand rupees" the words "rupees fifty thousand"
shall be substituted.

3. In the said Act, in Section 7,-----
(a) in clause (1) for the word "seven" the word
"ten" shall be substituted; and
(b) clause (j) shall be omitted.
