WHEREAS it is expedient to amend the Baluchistan Canal and Drainage Ordinance, 1980, for the purpose hereinafter appearing;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action:..

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No.1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:- ; ; :

i. (1) This Ordinance maybe called the Baluchistan Canal and Drainage (Amendment) Ordinance, 1984. : : . aii
