WHEREAS, It is expedient further to amend the
Balochistan Civil Servants Act, 1974 (Act No. IX of
1974), for the purpose hereinafter appearing;

it is hereby enacted as follows:-

1. (1) This Act may be called the Balochistan Civil
Servants (Amendment) Act, 2018.
- (2) It shall come into force at once.
2. In the Balochistan Civil Servants Act, 1974 (Act
IX of 1974), in section 22, in the proviso to sub-section
(2) the words “or to be promoted to a higher post”, shall
be omitted.
