Preamble. WHEREAS it is expedient further to amend the Baluchistan Civil Servants Act, 1974 (IX of 1974) for the purpose hereinafter appearing:

NOW, THEREFORE, in exercise of the powers

conferred by Article 128 of the Constitution, read with

Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Balu-

chistan is pleased to make and promulgate the following Ordinance:

1A .

Short title and/1. (1) The Ordinance may be called the Baluchis-commencement. Act/ Civil Servants (Amendment) Ordinance, 1982.

(2) It shall come into force at once and shall be deemed to have taken effect from 19th June, 1982.
