Preamble. WHEREAS it is expedient further to amend the Baluchistan Civil Servants Act, 1974, for the purpose hereinafter appearing:

\_ AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action:

NOW, THEREFORE, in exercise of the Powers conferred by Article 128 of the Constitution read with Article 2 of the Provisional Constitution Order, 1981 (CMLA Order No. 1<sup>st</sup> of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance :-

Short title and 1. (1). This Ordinance may be called the Baluchistan Civil Servants (Amendment) Ordinance, 1984.

(2) It shall come into force at once and shall be deemed to have taken effect on the first day of July, 1984.
