AND WHEREAS the Governor of Balochistan is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of Article 4 of the Provisional Constitution (Amendment) Order, 1999 (Chief Executive's Order No. 9 of 1999) and in exercise of all powers enabling him in that behalf, the Governor of Balochistan is pleased to make and promulgate the following

Ordinance:-

term as Government may determine.

(3) The Managing Director shall be the 'Chief Executive  
Officer of the Authority.

(4) The Managing Director on authorization by Governing  
Body shall perform such duties and exercise such powers as are  
assigned to them by or under this Act.

(5S) When the Managing Director is absent from duty for any  
reason or is unable to perform the functions of his office: Governing  
Body/Chairman may nominate some one to perform the duties of  
the Managing Director."
