to provide for making compulsory teaching of the Holy Qur'an to Muslim  
students in all educational institutions in Balochistan.

Preamble. WHEREAS, it is expedient to provide for making  
compulsory teaching of the Holy Qur'an to Muslim students in  
all educational institutions in Balochistan and for the matters  
connected therewith and ancillary thereto:

It is hereby enacted as under:

Short title, Le (1) This Act may be called "The Balochistan  
extent, Compulsory Teaching of the Holy Qur'an Act, 2023".

sadtuntie ae (2) It shall extend to the whole of Balochistan.

(3) It shall come into force at once.

(4) It shall apply only to Muslim students in  
all educational institutions in Balochistan.

Definitions. 2. In this Act, unless there is anything repugnant in

the subject or context, -

(a) "Act" means the Balochistan Compulsory  
Teaching of the Holy Qur'an Act, 2023;

(b) "Educational institutions" means any school,  
college, institute, or otherwise by whatever  
name called for, established and setup in public

or private sector for imparting education to  
students irrespective of its status whether

teaching of the  
Holy Qur'an.

Powers to make

registered or not registered with the  
Government or any other body;

“Government” means the Government of  
Balochistan;

(d) “Naazrah Qur'an” means learning of  
Tajweed and proper recitation by sighting of  
the Arabic text using rules of Tajweed;

(e) “Prescribed” means prescribed by rules  
made under this Act; and

(f) “Rules” means the rules made under this  
Act.

3} (1) There shall be, in all educational institutions,  
compulsory teaching of, -

(a) the Naazrah Qur'an in classes, grades  
or, as the case may be, levels I to V in  
prescribed manner; and

(b) the translation of the Holy Qur'an in  
classes, grades or, as the case may be,  
levels VI to XII in such prescribed  
manner that the entire Holy Qur'an is  
completed upto class, grade or, as the  
case may be, level XII.

(2) The Government shall ensure

implementation of the Act in the manner as may be

prescribed.

4. The Government may, by notification in the official

Gazette, make rules for carrying out of the purposes of  
this Act.

5. The provision of this Act shall be in addition to, and not in derogatory of any other law for the time being in force.
