WHEREAS it is expedient to  
the Governor with certain powers in

AND WHEREAS the Governor is  
Satisfied that circumstances exist which render  
it necessary to take immediate action;

- NOW, THEREFORE, in pursuance of the  
Proclamation of the fifth day of July, 1977, read  
with Laws (Continuance in Force) Order, 1977  
(CMLA Order, No. 1 of 1977), and in exercise  
of all powers enabling him in that behalf, the

Governor is pleased to make and promulgate  
the following Ordinance:—

(1) This Ordinance may be called the  
Baluchistan Corporation Employees  
(Special Powers) Ordinance, 1978.

(2) It shall come into force at once.

In this Ordinance, unless there is  
anything repugnant in the subject or context,  
“person in Corporation service” means every  
person who is in the employment of a Corpora-  
tion or an institution set up, established, managed  
or controller by the Government of Baluchistan,  
and include the Chairman and the Managing  
Director of, and the holder of any other office  
In, such Corporation or institution.

A person who is removed from service

Or reverted to a lower post or grade under section

may, within fifteen days from the date of

receipt of order of removal or reversion prefer  
a representation to the Governor:

Provided that, where the order of  
removal or reversion has been made by the  
Governor, such person may, within the time  
aforesaid, submit to the Governor a petition for  
review of the order.

Service of Corporation is hereby decla-  
red to be Service of Baluchistan and every person  
in Corporation service who is removed from  
service, or reverted to a lower post or grade,  
under this Ordinance, not being a person who  
is on deputation to a Corporation from any  
Province, shall be deemed to be a civil servant  
for the purposes of the Baluchistan Service  
Tribunal Act, 1974 (V of 1974).
