REGULATION, 1947

(Baln Reg. IIT of 1947)

[22TM December, 1947]

A Regulation to confer certain special powers upon
officers of the armed forces in certain disturbed areas of
Balochistan.

WHEREAS it is expedient to provide for the conferment
of certain special powers upon officers of the armed forces in
certain disturbed areas of Balochistan;

It is hereby enacted as follows:-

1. (1) This Regulation may be called the Balochistan
Disturbed Areas (Special Powers of Armed Forces) Regulation,
1947.

(2) It extends to the whole of [Balochistan].

(3) It shall come into force at once.

2. Any commissioned officer, warrant officer or *non
commissioned officer of the Pakistan military or air forces may,
in any area for the time being declared by notification under
section 3 of the Balochistan Disturbed Areas Regulation, 194774,
to be a disturbed area -

(a) exercise the powers conferred by section 5 of
the said Regulation upon a police officer not
below the rank of a Sub-Inspector;

(b) arrest without warrant any person who _ has
committed a cognizable offence, or against
whom a reasonable suspicion exists that he has
committed or is about to commit a

cognizable offence;

(c) enter and search, without a warrant, any premises

Spelling of the word "Baluchistan", wherever it appears in this Regulation, is corrected by insertion of letter "o" instead of "u",

to make any such arrest as aforesaid, or to secure
release and freedom of any person
believed to be wrongfully —_restraineded —_ or
confined, or recover any property reasonably
suspected to be stolen property, or any arms
believed to be unlawfully kept, in such premises.

3. No prosecution, suit or other legal proceeding shall be
instituted except with the previous sanction of the 'Central
Government, against any person in respect of anything done or
purporting to be done in exercise of the powers conferred, by
section 2.
