(Bill No.18 of 2022), having been passed by the Provincial Assembly of Balochistan on 26th April,

2022 and assented to by the Governor Balochistan, on 28th April, 2022 is hereby published as
an Act of the Balochistan Provincial Assembly.

ACT

to amend the Balochistan Factories Act, 2021 (Act No. XIX of 2021).

Preamble. It is necessary to amend the Balochistan Factories Act, 2021 (Act
No. XIX of 2021) for the purpose to omit obsolete provisions, facilitate
enforcement and to ensure effective implementation of the provisions
regarding working conditions in the factories of the province and for other
purposes.

It is hereby enacted as follows: --

Short title and commencement. 1. (1) This Act shall be called the Balochistan Factories
(Amendment) Act, 2022.

(2) It shall come into force at once.

Amendment of Section 9, 2: In Balochistan Factories Act, 2021 (Act No. XIX of 2021),
Act No. XIX of 2021. hereinafter referred to as the said Act, in section 9, sub-section (5) shall be
omitted.

Amendment of Section 15, 3. In the said Act, in section 15, in sub-section (1), in clause (d), sub-
Act No. XIX of 2021. clause (iii) shall be omitted.

Omission of section 24, 4. In the said Act, section 24 shall be omitted.
