Preamble. WHEREAS it is expedient to amend the Baluchistan Finance

Ordinance, 1941 (IX of 1981), in the manner hereinafter appearing;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Article 123 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:-

Short title and 1. (1) This Ordinance may be called the Baluchistan Finance Amendment Ordinance, 1981.

(2) It shall come into force at once and shall be deemed to have taken effect from 1st July, 1981.

Amendment of 2. In Section 1 of the Finance Ordinance, 1981 (IX of 1981) (hereinafter referred to as the said Ordinance), after sub-section (2) the following new sub-section shall be added, namely:—

“(3) This Ordinance shall apply to whole of Baluchistan, except the Tribal areas.”

4. For Section 4 of the said Ordinance, the following shall be
