WHEREAS, it is expedient to amend the Baluchistan Food Authority Act, 2014 (Act No. VI of 2014), in the manner hereinafter appearing.

It is hereby enacted as follows;

1. (1) This Act may be called the Baluchistan Food Authority (Amendment)

Act, 2021.

(2) It shall come into force at once.

2. In the Baluchistan Food Authority Act, 2014 (Act No. VI of 2014),

hereinafter referred to as "the said Act", in section 2,

(a) after clause (c) the following new clause shall be inserted: -  
(ca) "Appellate Committee" a committee constituted to address the grievances of a person aggrieved by any action taken under section (20) of the Act.

(b) after clause (n) the following new clause shall be inserted: -  
(na) "Food Safety Team" comprising of two or more technical officers headed by a senior officer as Supervisor.

3. In the said Act, in section 4, for sub-section (1), the following shall be substituted: -

(1) The Food Authority shall consist of the: -

(a) Provincial Minister/Advisor for Food Department. Chairperson.

(b) Secretary Government of Balochistan  
Food Department. Member.

(c) Secretary Government of Balochistan  
Finance Department. Member

(d) Secretary Government of Balochistan  
Health Department. Member

(2) In the said Act, for sub-section (8), the following shall be substituted:

(8). The Food Authority shall meet at least twice in a year.  
The Director General, with the approval of Chairperson can call  
a special meeting of the Food Authority.”

In the said Act, in section 9 for sub-section (1), the following shall be

“(1) The Food Authority may establish one or more Scientific Panels,  
which shall consist of the following—

(a) Director General, Balochistan Food Authority (Convener);

(b) a representative, having background of food science or technology, of  
an organization established for determining standards and quality of food;

(c) a representative, having background of food science or technology, of  
an organization established for scientific or industrial research on food;

(d) a food technologist or scientist;

(e) a medical practitioner registered with Pakistan Medical Commission;  
and

(f) a registered Nutritionist from Health Department Government, of  
Balochistan.

(4) The Director General shall constitute Food Safety Team or Teams comprising two or more Food Safety Officers Headed by a senior officer as supervisor.

(5) Notwithstanding anything herein above mentioned in sub section (2), the Director General in the public interest may confer the powers of a Food Safety Officer on a Government Servant. .

In the said Act, after section 20, a new section 20A with margine}  
heading "Power to ban the sale and purchase of food" shall be

inserted:

(1) If the Director General has reasons to believe that the health risk condition exists with respect to sale and purchase of any food or that some food is not in compliance with the Act, Rules or Regulations, he may, after recording reasons order immediate ban on sale and purchase of the said food in the market.

(2) Any person who is aggrieved by any action taken under this section, may, in the prescribed manner, prefer an appeal to the Secretary Government of Balochistan, Food Department.

(3) The Secretary, Government of Balochistan, Food Department on its own may accord on the application of an aggrieved person, set

aside or modifies an order made under sub-section (1)."

In the said Act, for section 27, the following shall be substituted: -

"27, If any person, without reasonable cause fails to comply with any order or notice issued by the Food Authority, the Director General, the Food Safety Officer or Food Safety Team, he shall be liable to imprisonment for a term which may extend to six months and fine which may extend to five hundred thousand rupees."

In the said Act, for section 30, the following shall be substituted: -

30. "If a person makes a false or misleading statement, provides false or misleading information or produces any false or misleading document before the Food Authority, the Director General the Food Safety Officer or a Food Safety Team, he shall be liable to imprisonment for a term which may extend to one year and fine which may extend to five hundred thousand rupees",

In the said Act; in section 39, for sub-section (1) and (2), the following

shall-be substituted: -

(1) On information received from a Food Safety Officer, Food Safety Team or any other person, the Food Authority or the Director General if so authorized by the Food Authority may, for reasons to be recorded in writing,-

(a) order prosecution of a person under this Act;

(b) suspend or cancel the license of the food operator;

(c) impose on the food operator fine which may extend to five hundred thousand rupees; or

(d) decide, if the circumstances so warrant, not to take any action on the information.

(2) If the Food Authority or the Director General, as the case may be, cancel the license or imposes fine on a food operator, the food operator may, within fifteen days of the communication of the order prefer an appeal against such order to the Secretary Government of Balochistan Food Department.

In the said Act, in section 40, after the words “shall be” for the word “tried” the word “trialed” shall be substituted.

In the said Act, in section 43, in sub-section (1), for the word “try” the word “trial” shall be substituted.

In the said Act, in section 50, sub-section (3) shall be omitted.

In the said Act, for Section 51, the following shall be substituted: -

“The Food Authority may delegate, subject to such conditions and restrictions as may be specified in the order, any of its functions to a committee constituted by the Food Authority, the Director General or any other officer of the Food Authority, except the function to—

- (a) frame or amend regulations;
- (b) formulate standards, procedures, processes and guidelines in relation to any aspect of food; and
- (c) approve the annual report, annual budget and audited accounts.

In the said Act, in Section 52, for the words “Food Authority” appearing before the words “may” the words “Director General” shall be substituted.
