An Ordinance to restrict the number of goats in
[Balochistan].

Preamble. WHEHEAS It is expedient in the public interest to
restrict the number of goats in the Province of *[Balochistan];

NOW, THEREFORE, in pursuance of the Presidential
Proclamation of the seventh day of October, 1958, and in
exercise of all powers enabling him in that behalf, the Governor
of West Pakistan is pleased to make and promulgate the
following Ordinance:-

Short title and 1. (1) This Ordinance may be called the *[Balochistan]
extent. Goats (Restriction) Ordinance, 1959.

(2) It extends to the whole of the Province of
[Balochistan] except *[* * *] *[the Tribal Areas.]

Definitions. 2. In this Ordinance. unless the context otherwise requires,
the following expressions shall have the meanings hereby
respectively assigned to them, that is to say—

(i) "Government" means the Government of
[Balochistan];

(ii) "prescribed" means prescribed by rules made
under this Ordinance;

(iii) "slaughter-house" means any building, premises
or place used in connection with the
business of killing or slaughtering animals
intended for human consumption, and_ shall
include a public slaughter-house maintained by a
local authority and a private slaughter-house

unlawful—

(a) after twelve months of the publication of the notification, to graze or pasture goats on any land; and

(b) after eighteen months of the publication of the notification, to keep goats:

Provided that Government may in any area permit the keeping of goats subject to such conditions as may be prescribed.

4. Government may in such manner as may be prescribed regulate' the leading, driving, conducting or conveying of goats in any local area.

5. Government may in such manner as may be prescribed regulate the slaughter of goats including the proportion of the goats to the sheep that may be slaughtered in a slaughter-house on any day.

6. Any person who contravenes the provisions of section 3, section 4 or section 5 or such of the rules made under this Ordinance as may be specified shall be punished with imprisonment which may extend to six months, or with fine which may extend to ?[five thousand rupees], or with both, and in addition thereto the goat concerned in the offence shall be forfeited to Government.

7. Notwithstanding anything contained in the Code of Criminal Procedure, 1898*, an offence punishable under this Ordinance shall be cognizable and bailable within the meaning of the said Code.
