An Ordinance to provide for the recovery of  
Government dues as arrears of land revenue in the Province of  
[Balochistan].

Preamble. WHEREAS it is expedient to provide for the recovery  
of Government dues as arrears of land revenue in the Province  
of \*[Balochistan], in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Presidential  
Proclamation of the seventh day of October, 1958, and in  
exercise of all powers enabling him in that behalf, the Governor  
of West Pakistan is pleased to make and promulgate the  
following Ordinance:—

Short title, extent 1. (1) This Ordinance may be called the \*[Balochistan]  
and Government Dues Recovery Ordinance, 1962.

t. (2) It extends to the whole of the Province of

[Balochistan] except the \*[Tribal Areas]°.

(3) It shall come into force at once.

Definitions. 2. In this Ordinance, unless the context otherwise requires,  
the following expressions shall have the meanings hereby  
respectively assigned to them, that is to say—

(a) "defaulter" means a person from whom any dues  
are recoverable by Government, and includes a  
person who is responsible as surety for the  
payment of any such dues; and

(b) "Government" means the Government of the  
Province of °[Balochistan].

This Ordinance was promulgated by the Governor of W.P. on 21"May, 1962; published in the W.P. Gazette (Extraordinary), da  
25"May, 1962, pages 2129-2130; saved and given permanent effect by Article 225 of the Constitution of the Islamic Republic of  
(1962).

Notification by the 3. (1) Government may, by notification declare that Government. any dues or class of dues recoverable by Government shall be recoverable from the defaulters as if such dues were arrears of

land revenue.

(2) On the publication of a notification under sub-section (1) any such dues shall be recoverable under the Revenue Recoveries Act, 18907 (Act I of 1890) as arrears of land revenue.

Power to make 4. Government may make rules for the purpose of giving rules. effect to the provisions of this Ordinance.
