1. (1) This Act may be called the Balochistan Government  
Educational and Training Institutions (Amendment) Act, 2007.

(2) It shall come into force at once.

2 In the Balochistan Government Educational and Training

Institutions Ordinance 1960 after clause (b) of Section 2, the following  
new clause shall be added.

“(bb) Vice Chairman means Vice Chairman of the Board”

3. In the said Ordinance, for Section 4 the following shall be  
substituted namely:

4. The Board shall consist of :-

- (1) Governor Balochistan Chairman
- (2) Minister for Education. Vice-Chairman
- (3) Chief Secretary Balochistan. Member
- (4) Additional Chief Secretary (Dev) P&D. Member
- (5) Secretary Education. Member
- (6) Secretary Finance. Member
- (7) Secretary Law. Member
- (8) Representative of HQ 12 Corps. Member
- (9) Respective District Nazims. Member
- (10) Additional Secretary (Dev) Edu Member/  
Secretary
- (11) Principals of the Colleges. Honorary  
Members

3. In the said Ordinance Section 6 shall be omitted.

6. In the said Ordinance in clause (e) of Section 8 after the word

“Chairman” the word “Vice-Chairman” shall be added.
