to further amend the Balochistan Government Employees Benevolent Fund Act. 2018 (Act No.XV of 2018)

Preamble. WHEREAS it is expedient further to amend the Balochistan Government Employees Benevolent Fund Act. 2018

(Act No. XV of 2018), in the manner hereinafter appearing:
It is hereby enacted as follows:-

Short title, and 1. (1) Uhis Act may be called The Balochistan Government commencement Employees Benevolent Fund (Amendment) Act. 2021.

(2) It shall come into force at once and shall be deemed

to have taken effect on and from S\$" day of October. 2020.

"(5) the lump sum Benevolent Fund shall be paid to a dismissed, removed, terminated or compulsory retired employee proportion to the years he/she had served."

shall be substituted.
