WHEREAS, it is expedient further to amend the Balochistan Government  
Educational and Training Institutions Ordinance. 1960 (XL of 1960) in the

manner herein after appearing:

AND WHEREAS, the Governor of Balochistan is satisfied that

circumstances exist which render it necessary to take immediate action:

NOW, THEREFORE, in exercise of the powers conferred by Article  
128 of the Constitution of the Islamic Republic of Pakistan, 1973, the  
Governor of Balochistan is pleased to make and promulgate the following  
Ordinances:-

| (1) This Ordinance may be called the Balochistan Government  
Educational and Training Institutions (Amendment) Ordinance. 2007.

(2) It shall come into force at once.

a In the Balochistan Government Educational and Training Institutions
