WHEREAS it' is expedient further to amend the Baluchistan Ground Water Rights Administration Ordinance, 1978, for the purpose hereinafter appearing ;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981, (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance :- t

1s (1) This Ordinance may be called the Baluchistan Ground Water Rights Administration (Amendment) Ordinance, 1984.

(2) It shall come into force at once.

me 2 slg the Baluchistan Ground Water Rights Admnistration Ordinance » 1978,
in.sectiop 4:-

a) in section 4, after the figure and full stop **4,«* the bracket and figure (1) shall be deleted.

(b) after clause (n) for the bracket and word "(e)" the bracket and word "(oye shall be substituted, and in the said clause at the end omit full stop and add the following :-

"who shall dispose of the same after providing the appellant an Opportunity of being heard.

(c) for clause (p), the following shall be substituted, namely:-

Vs The Provincial Water Board shall have the power to call for the record of any case relating 'to the water rights pending either before the District Water Committee or the Commissioner, to examine and satisfy itself as to the regularity, propriety and legality of the proceedings and may after _ hearing the parties likely to be affected, set aside any of the order or quash

the proceedings, if it considers that any material irregularity has occurred SO as to occasion a miscarriage of justice,
