(AMENDMENT) ORDINANCE, 2001.

ORDINANCE

further to amend the Balochistan Ground Water Rights  
Administration Ordinance. 1978 (1X of 1978).

Preamble. WHEREAS. it is expedient further to amend the Balochistan Ground  
Water Rights Administration Ordinance. 1978. in the manner hereinafter  
appearing:

Short title and

Amendment of  
section 3 of

Act [X of 1978.

Amendment of  
section 4 of  
Act IX of 1978.

AND WHEREAS. the Governor of Balochistan is satisfied that  
circumstances exist which render it necessary to take immediate action:

NOW THEREFORE, in pursuance of Article 4 of the Provisional  
Constitution (Amendment) Order, 1999 (Chief Executive's Order No. 9 of  
1999), and in exercise of all powers enabling him in that behalf. the  
Governor of Balochistan is pleased to make and promulgate the following  
Ordinance:-

I. (1) This Ordinance may be called the Balochistan Ground Water  
Rights Administration (Amendment) Ordinance, 2001.

(2) It shall come into force at once.

2. In the Balochistan Ground Water Rights Administration Ordinance.  
1978, hereinafter referred to as the said Ordinance. in clause (a) of sub  
section (1) of section 3, the word "Commissioner" shall be deleted.

3. In the said Ordinance, in section 4.-

(a) in clause (a) for the words "Deputy Commissioner" and "Extra  
Assistant Director Agriculture" the words "Executive District  
Officer (Revenue)" shall be substituted.

(b) in clause (0), for the words "Commissioner of the Division" the  
words "District Coordination Officer of the District" shall be  
substituted.

(c) in clause (p). for the word "Commissioner" the words "District  
Coordination Officer" shall be substituted.
