AND WHEREAS, the Provincial Assembly of Balochistan stands suspended in pursuance of the Proclamation of emergency of the fourteenth day of October, 1999, and the Government of Balochistan is satisfied that circumstances exist which render it necessary to take immediate action,

NOW THEREFORE, in pursuance of Article 4 of the 'Provisional Constitution' (Amendment) Order, 1999 (Chief Executive's Order No. 9 of 1999), and in exercise of all powers enabling him in that behalf, the Government of Balochistan is — pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Balochistan Information Technology Board Ordinance, 2001.

(2) It shall come in force at once.

2. (1) The Government may establish a Board to be called the Balochistan Information Technology Board.

(2) The Board shall be a body corporate having perpetual succession and a common seal with powers to acquire, hold and dispose of property and the said name sue and be sued.

3. (1) The Board shall consist of such number of members as may be appointed by the Government.

(2) The Government shall appoint one member as President of the Board.

(3) No act, proceedings or decision of the Board shall be invalid by reason of any vacancy or defect in the constitution of the Board.

4. The Board shall take all such measures as it deems necessary for the administration of its affairs and for promotion development and use of information technology.

5. (1) The — shall appoint Chairman of the Board

whose terms and conditions of service shall be such as may be determined by the Government.

(2) The Chairman shall perform such functions as may be assigned to him by the Board.

6. (1) The Board may delegate to any person any of its powers, duties and functions.

(2) The Chairman may delegate any of his powers including delegated powers to any officer of the Board.

7. (1) There shall be a fund known as Information Technology Board Fund which may vest in the Board and to which shall be credited all moneys received by the Board.

(2) The fund shall be kept in such custody and shall be utilized and regulated in such manner as may be prescribed by rules.

(3) The Government shall provide funds to Information Technology Board for its Secretariat and other necessary and incidental expenses.

8. (1) The budget of the Board shall be approved and\_ its accounts shall be maintained and audited in such manner as may be prescribed by rules.

9. The Board may employ such officers, advisors, consultant and employees in its services as may be necessary for the efficient performance of its functions in such manner and on such terms and conditions as may be prescribed by the Board.

10. The Government may make rules for carrying out the purposes of this Ordinance

I. If any difficulty arises in given effect to any provision of this Ordinance. the Government may make such order as may be necessary for removing the difficulty.
