AND WHEREAS the Provincial Assembly of Balochistan stands -  
suspended in pursuance of the Proclamation of Emergency of the fourteenth  
day of October, 1999 and the Governor of Balochistan is satisfied that  
circumstances exist which render it necessary to take immediate action:

NOW THEREFORE in pursuance of Article 4 of the

Provisional Constitution

(Amendment) Order, 1999 (Chief Executive's

order No.9 of 1999), and in exercise of powers enabling him in that behalf,  
the Governor of Balochistan, on the instructions of the Chief Executive of  
Pakistan, is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Balochistan Irrigation and  
Drainage Authority (Amendment ) Ordinance, 2000.

(2) It shall come into force at once.

2, In the Balochistan Irrigation and Drainage Authority Act, 1997,  
hereinafter referred to as the said Act, in section 26:-

(a) In sub section (2) ,for the words" Accountant General  
for the province" the words "Auditor General of Pakistan"  
shall be substituted.

(b) In sub section (4) for the words "Accountant General the  
Province" the words "Auditor General of Pakistan" shall be  
substituted.

3. In the said Act, section 32, shall be re-numbered as sub-section -
