‘equisation of | 3. . Notwithstanding anything contained in any other Law, a Lady Health Visitor shall be liable
arvice. " to serve the Province of Baluchistan for a period of at least three years, if so required by the

(a) if she has qualified as such on or after the first day of July, 1970, but before the com-
menzement of this Act, within one year of the day of commencement of this Act;

(b) if she qualifies after the commencement of this Act, within one year of her qualifying.
