ORDINANCE

to abolish land' revenue in the Province of Baluchistan.

WHERBAS it is expedient to abolish land revenue
in the Province of*Baluchistan.

Preamb'e. ':tAND .WHEREAS. the Governor is satisfied that

circumstances exist which render it necessary to take imme-
diate action;

- NOW THEREFORE, in pursuance of the procla-

mation of the fifth day-of July; 1977, ead with the Law (Conti-
nuance in Force) Order, 1977 (CMLAORBEP. NO.1 of 1977)
and in exercise of all powers enabling him in that behalf,
the 'Governor of Baluchistan jis pleased to make and promul-
gate the following Ordinance :—

"Short title OL (1) This Ordinance may.be. called the Baluchistan
extent and Larid Revenue (Abolition) Ordinance, 1977.
commencement. '

(2) It shall extend to the whole of the Proyince of
' Baluchistan. «xcept Tribal Areas.

(3) It.shal' come into force at once and shall 'be
deemed to have taken effect on and from 5th
Day of January, 1977.

Abolition of 2. Notwithstanding anything to the.contraiy contained

Land Revenue. in he Baluchistan, Land Revenue Act,1967, or any other law
for the tim2 being in force, no land revenue, .as-defined in the
Baluchistan Land Revenue Act, 1967, becoming due as
from 'Rabi 1976-77 shall be assessed, levied or charged.

Saving. 3, ' Nothing contained 'in Section 2 of this Ordinance
shall be construed to affect the liability of any. person to pay:

the land revenue which had become due before Rabi 1976-77, ~

or the assessment, levy, charge and-collection-of the land revenue
'or any dues recoverable as land.1evenue for the period before
Rabi 1976-77, which shall continue to ibe done under the
provisions of the Baluchistan Land Revenue Act, 1976.
