Governor of Baluchistan is pleased to make and promulgate  
the following Ordinance:—

1. (1) This Ordinance may be called the Baluchistan Land  
Revenue (Second Amendment) Ordinance, 1978

(2) It shall come into force at once and shall be deemed

\_to have taken effect on and from the harvest of  
Rabi Crop 1976-77, .

2. \_ In the Baluchistan Land Revenue Act, 1967 (Act XVI
