Preamble

WHEREAS it is expedient further to amend the  
Baluchistan Land Revenue Act, 1967 (XVII of 1967):

AND WHEREAS the Governor is satisfied that  
circumstances exist which render it necessary to take  
immediate action;

NOW, THEREFORE, in exercise of the powers  
conferred by Article 128 of the Constitution, read  
with Article 2 of the Provisional Constitution Order,  
1981 (C.M.L.A. Order No. 1 of 1981), the Governor  
of Baluchistan is pleased to make and promulgate  
the following Ordinance: -

1. (1) This Ordinance may be called the Baluchistan  
Land Revenue (Second Amendment) Ordinance, 1983.

(2) It shall come into force at once and shall be  
deemed to have taken effect from Rabi Season 1982-83,  
commencing from 1st day of October, 1982.

in the Baluchistan Land Revenue Act, 1967  
in sub-section (1) of Section 66,

, the following new clause shall be  
, Namely:-

“(f) land on the produce of which Ushr or  
contribution in lieu thereof has been charged  
in accordance with the Zakat and Ushr
