Preamble. WHEREAS it is expedient to validate certain taxes, rates, tolls or fees levied, charged, collected or realized under the Baluchistan Local Government Ordinance, 1980, or rules thereunder, in the manner - hereinafter appearing;

; AND WHEREAS the Governor is Satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by +————— Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance :—

Short title and 1. (1) This Ordinance may be called the Baluchistan Local Councils (Validation of Tax) Ordinance, 1982.

(2) It shall come into force at once.

Validation 2. Notwithstanding anything contained in the Baluchistan Local Government Ordinance, 1980 (No. 1 of 1980) the Baluchistan Local Councils (Imposition of Taxes) Rules, 1981, or in any other law or rules,

or any judgment, order or decree of any court—

(a) any tax, rate, toll or fees levied, charged, collected or realized by a Local Council on or after 1.7.1981, shall be deemed to have been validly levied, charged, collected or realized, as the case may be;

(b) where any such tax, rate, toll or fees have not been

paid or realized before the coming into force of this Ordinance, the same shall be recoverable in accordance with the Ordinance and the rules. “ag
