AND WHEREAS the Governor of Baluchistan is

necessary to take immediate action;

NOW THEREFORE in pursuance of the procla-
mation of the fifth day of July, 1977, read with the Law
(continuation in Force) Order 1977 (CMLA ORDER
No. 1 OF 1977) and exercise of all powers enabling
him in that behalf the Governor of Baluchistan is
